FORT RILEY DEER HUNTING FACT SHEET 2022

The military mission has precedence over the announced hunting season. The Fort Riley Military Reservation or any portion of it may be closed at any time without prior notice. Additional security measures may be implemented without notice, resulting in additional access restrictions to those explained in this document.

1. AVAILABLE FORT RILEY DEER PERMIT TYPES

- **a.** Active Duty Stationed at Fort Riley Archery and Firearms Permit. Available only to all Active Duty Military Service Members stationed at Fort Riley. This permit is good for all deer seasons. See section 2 part d.1 for more information.
- **b.** Family Member Archery and Firearms Permit. Available only to all Family members (as Family Member is defined in 5 CFR 630.101) of Active Duty Military Service Members stationed at Fort Riley. This permit is good for all deer seasons. See section 2 part d.1.1 for more information.
- **c.** Non-Active Duty Archery and Firearms Deer Permit. Available to all individuals who are not eligible for the permits described in 1.a or 1.b above. This permit is good for all deer seasons. See section 2 part d.1.2 for more information.
- **d.** Non-Active Duty Firearms Only Deer Permit. Available to all individuals who are not eligible for the permits described in 1.a or 1.b above. This permit is good during any firearms or muzzleloader deer season. See section 2 part d.1.3 for more information.

2. DEER HUNTING REQUIREMENTS

a. Kansas Permits and Licenses. Each deer hunter must obtain all State of Kansas required permits and licenses. These are available at County Clerk Offices, any Kansas hunting and fishing license vendor, or over the internet at <u>http://www.kdwpt.state.ks.us/news/license-permits</u>.

b. 2022-2023 Fort Riley iSportsman Permit (No cost). <u>All</u> hunters must complete the 2022 Outdoor Recreation Briefing online and obtain the 2022-2023 Fort Riley iSportsman permit at <u>https://fortriley.isportsman.net</u>. Go to the "My Account" tab on the webpage to complete the briefing and print the permit.

c. 2022 Fort Riley Hunting Access Permit (\$25). Non-exempt hunters must possess a 2022 Fort Riley Hunting Access Permit available online at <u>https://fortriley.isportsman.net</u>. Exemptions are persons < 16 or \geq 65 years of age and Kansas Disabled Veterans (30% or greater disability or possessing a KDWPT Exempt license).

d. 2022 Fort Riley Deer Hunting Permit (No cost). All deer hunters must complete the 2022 Fort Riley Deer Hunt Briefing online at <u>https://fortriley.isportsman.net</u>. Go to the "My Account" tab on the webpage to take the briefing and quiz. The Fort Riley iSportsman, Hunting Access and Deer Hunting Permits must be available to game wardens for viewing while hunting/scouting. Requirements and limitations for deer permits types are:

d.1. Active Duty Stationed at Fort Riley Archery and Firearms Permits are unlimited. Active Duty Service Members stationed at Fort Riley will select the "2022 Active Duty Archery & Firearms Deer Permit" after completing the 2022 Outdoor Recreation and 2022 Deer Safety briefings online at <u>https://fortriley.isportsman.net</u> beginning 20 August 2022.

d.1.1. Family Member Archery and Firearms Deer Permits will be unlimited. These permits will be added to family members' iSportsman accounts by Fort Riley's Environmental Division Office after the Active Duty Service Member informs the Environmental Division Office of their family member's desire to deer hunt. Family members must watch the 2022 Outdoor Recreation and 2022 Deer Safety briefings online at https://fortriley.isportsman.net prior to receiving their deer permit.

d.1.2. Non-Active Duty Archery and Firearms Deer Permits will be issued first come, first served to a maximum of <u>200</u> persons at the Fort Riley Environmental Division Office from 07:00-12:00 Saturday, 20 August 2022. Persons with a CURRENT printed iSportsman permit and valid ID who have viewed the 2022 Outdoor Recreation and 2022 Deer Safety Briefings will receive priority over those who have not. Permits will not be issued until all briefings have been viewed.

d.1.3. Non-Active Duty Firearms Only Deer Permits are unlimited and will be available online at <u>https://fortriley.isportsman.net</u> to individuals beginning 1 September 2022 after they complete the 2022 Outdoor Recreation and 2022 Deer Safety briefings online at <u>https://fortriley.isportsman.net</u>.

3. SEASON OPTIONS: The following deer seasons are available as defined below. All persons recreating on Fort Riley, to include hunting, scouting and mentoring must check-in and check-out each day they recreate using the Fort Riley iSportsman system:

a. Special Archery-Only Season: September 1-11, 2022 & Jan. 1-31, 2023. Hunters may only hunt in areas listed as open for archery deer hunting on the particular day they wish to hunt. The Special Archery-Only Season is valid only on the Fort Riley Military Reservation. Eligible individuals (see below) will be authorized to take an antlered deer during this season. Eligibility to hunt this season is limited to the following individuals with valid permits and licenses who have obtained special written authorization to hunt during this special season from the Fort Riley Environmental Division Office. Please call 785-239-6211 and leave a message to schedule a time to receive the special written authorization. Eligible individuals are:

a.1. Military and Civilian Personnel stationed at Fort Riley with an impending deployment date between 1 September and 30 November 2022. Deployment papers or Commander Confirmation must be provided.

a.2. Military and Civilian Personnel stationed at Fort Riley on leave from deployment who will not be redeployed to Fort Riley by 1 December 2022. Redeployment papers or Commander Confirmation must be provided.

b. Early Youth/Disabled Season: September 3-11, October 8-10 2022. Any Kansas Youth Deer Permit holder or disabled hunter (meeting State of Kansas requirements to hunt the Disabled season) with a valid Fort Riley Deer Hunting Permit and other required Fort Riley and State of Kansas permits-licenses may hunt during these dates using any legal firearm or archery equipment allowed by the State of Kansas. Hunters may only hunt in areas listed as open on the particular day they wish to hunt for the method of deer hunting they choose.

c. Traditional Muzzleloader Season: September 12-25, 2022. Any hunter with a valid Fort Riley Firearm Deer Hunting Permit and other required Fort Riley and State of Kansas permits and licenses may hunt during this season using only traditional caplock or flintlock muzzleloaders. Inline muzzleloaders are <u>NOT</u> legal equipment on Fort Riley during this season. Hunters may only hunt in areas listed as open for muzzleloader deer hunting on the particular day they wish to hunt.

d. Regular Archery Season: September 12 – December 31, 2022. Any hunter with a valid Fort Riley Archery Deer Hunting Permit and other required Fort Riley and State of Kansas permits and licenses may hunt during this season using any legal archery equipment allowed by the State of Kansas. Hunters may only hunt in areas listed as open for archery hunting on the particular day they wish to hunt. Archery hunters must follow blaze orange requirements during any firearm deer season on Fort Riley (see 6d below).

e. Antlerless Only Firearms Season: November 25-27, 2022. Any hunter who possesses a Fort Riley Firearms Deer Hunting Permit and other required Fort Riley and State of Kansas permits and licenses may hunt for antlerless whitetail deer using any legal equipment allowed by the State of Kansas. To provide a safe and high quality deer hunt the maximum number of hunters who will be allowed to check in each day to hunt on Fort Riley north of Rubio Road is 230 split into two management areas. The area west of old Hwy 77 (Maneuver Areas A, D, G, H, J, K, N, O & Q) will allow 115 hunters per day. The area East of old Hwy 77 (Maneuver Areas B, C, E, F, I, L, M & P) will allow 115 hunters per day. You may check-out of a management area and check-in to a different management area during the same day through the automated system, but may only be checked-in to a single area at any time. If either of the management areas is full you will not be allowed to check in to the area until someone checks out. Hunters hunting east of Old Hwy 77 (Maneuver Areas B, C, E, F, I, L, M & P) may only use any legal bow, muzzleloading rifle or muzzleloading handgun (Inlines are legal during this season), or any legal shotgun. Hunters south of Rubio Road may only use legal bow hunting equipment. An unlimited number of archery hunters will be allowed to check in to hunt south of Rubio Road each day. Hunters using firearms may harvest only antlerless deer. Archery hunters may harvest antlered or antlerless deer.

f. Regular Firearms Season: December 17-23 & 26-27, 2022. Any hunter who possesses a Fort Riley Firearms Deer Hunting Permit and other required Fort Riley and State of Kansas permits and licenses may hunt using any legal equipment allowed by the State of Kansas. To provide a safe and high quality deer hunt the maximum number of hunters who will be allowed to check in each day to hunt on Fort Riley north of Rubio Road is 230 split into two management areas. The area west of old Hwy 77 (Maneuver Areas A, D, G, H, J, K, N, O & Q) will allow 115 hunters per day. The area East of old Hwy 77 (Maneuver Areas B, C, E, F, I, L, M & P) will allow 115 hunters per day. You may check-out of a management area and check-in

to a different management area during the same day through the automated system, but may only be checked-in to a single area at any time. If either of the management areas is full you will not be allowed to check in to the area until someone checks out. Hunters hunting east of Old Hwy 77 (Maneuver Areas B, C, E, F, I, L, M & P) may only use any legal bow, muzzleloading rifle or muzzleloading handgun (Inlines are legal during this season), or any legal shotgun. Hunters south of Rubio Road may only use legal bow hunting equipment. An unlimited number of archery hunters will be allowed to check in to hunt south of Rubio Road each day.

3. BAG LIMIT and TAGGING INSTRUCTIONS: The bag limit for deer on Fort Riley is consistent with the State of Kansas. Fort Riley falls into Deer Management Unit 8 for Kansas. Each deer harvested must be legally tagged with a valid Kansas deer paper or e-tag permit per Kansas Regulations prior to moving the carcass.

4. FIREARMS SPECIFICS: Fort Riley Regulation 190-1 requires registration of ALL firearms brought on-post with Fort Riley. Firearms must be registered regardless of military or civilian status of the hunter. For more information about the registration procedures, review the Privately Owned Firearms Guide under the Regulations tab at http://fortriley.isportsman.net. Firearms may be registered at the Visitor Control Center, building 885, right off exit 301, I-70, Marshall Army Airfield. For additional questions contact the Visitor Control Center at (785) 239-2982. In addition, FR Reg.190-1 prohibited practices includes carrying concealed on one's person any weapon. Kansas concealed carry handgun permits and those issued by other states are <u>not</u> recognized on Fort Riley. All firearms must be unloaded and cased or locked while being transported in a vehicle on Fort Riley. Ammunition must be stored separately from the firearm being transported in a vehicle.

5. OFF-LIMITS AREAS: The IMPACT AREA and Douthit Range Complex are OFF-LIMITS at all times. Other areas will be off-limits during all or part of the deer seasons. Listings and/or maps of off-limits areas will be posted online at: http://fortriley.isportsman.net.

6. MISCELLANEOUS

a. A current Fort Riley iSportsman "Vehicle Pass" must be prominently displayed in the front windshield on the driver's side of all motor vehicles being used while hunting or recreating on Fort Riley.

b. Motorized vehicles are restricted to roads that are specifically marked on the Fort Riley Outdoor Recreation Map. The only exception to this restriction is to retrieve a downed deer or elk.

c. All deer harvested on Fort Riley should normally be field-dressed in the field where taken with deposition of entrails at least 100 feet from any road. The Environmental Office encourages carcasses to be double bagged, tied shut and disposed of in general refuse. Carcasses and entrails must not be disposed of in any live waterway that contains water or normally contains water to include ponds, lakes, creeks, rivers and dry creek beds. All deer must be covered or otherwise completely concealed from view of those outside the vehicle while being transported on Fort Riley. Deer carcasses that are not taken directly to a processer off post must

be completely covered from view at all times until completely consumed or otherwise properly disposed of. Carcasses of deer or other big game harvested off Fort Riley shall not be disposed of on Fort Riley.

d. During any Fort Riley firearms deer season, all individuals in areas open to firearms deer hunting shall wear the following blaze orange clothing at all times: a cap or hat, and an outer cover of a coat, vest, sweater, coveralls, or shirt. The outer cover must have at least 100 square inches of blaze orange colored surface visible on the front and 100 square inches of blaze orange colored surface visible on the front and 100 square inches of blaze orange colored surface on the back. In addition, during the time period September 1 - May 31, all recreationists in a training or maneuver area who are not in a stationary position must wear at least one of the following articles of visible, external apparel with at least 50 percent of its surface area solid blaze orange in color: hat, cap, vest, coat, jacket, sweatshirt, shirt or coveralls.

e. State of Kansas and Fort Riley regulations must be followed in regards to legal firearms, bows and other equipment except where Fort Riley regulations are more restrictive, in which case Fort Riley regulations must be followed.

f. Any individual who is actively assisting any big game hunter (as defined by the State of Kansas) must have a Fort Riley Hunting Access Permit, unless exempt, available online at https://fortriley.isportsman.net.

g. Deer drives are prohibited on Fort Riley. A deer drive is defined as a deliberate action by one or more persons (armed or unarmed) whose intent is to cause deer to move within firearm range of one or more hunters. Individuals who are within eyesight <u>and</u> hearing of one another, as Mentor-Mentee or Adult-Child hunts are not defined as a deer drive.

h. All deer stands and ground blinds must be permanently marked/engraved in a visible manner with the hunter's KDWP#. These markings must be marked within 6 feet of ground height and blinds must be marked above the entrance. Blinds and stands used during a Fort Riley firearms season must have no less than 100 visible square inches of blaze orange per side while occupied. Stands and blinds may not be placed on Fort Riley before August 1, 2022 and must be removed no later than February 15, 2023. Reminder, fires from prescribed burning and military training occur throughout the year on the installation. Fort Riley **IS NOT** responsible for damage to or loss of personal property. Therefore the placement of hunting blinds, trail cameras, and other personal effects are done at your own risk.

i. Baiting is prohibited on Fort Riley.

(1) No person shall place, deposit, expose, or scatter bait on Fort Riley. (2) Nothing in this regulation shall prohibit hunting or taking of wildlife over standing crops, or where grain is scattered as the result of normal agricultural operations, weather conditions, or by official personnel for wildlife management purposes. (3) "Bait" means any grain, fruit, vegetable, nut, hay, salt, sorghum, feed, other food, or mineral that is capable of attracting wildlife. Liquid scents and sprays are not considered bait, however they may only be used as a drag or cover scent and may not be directly poured on the ground. (4) Bait found on Fort Riley should be reported to the Environmental Division Office at (785) 239-6211 or Game Warden section at (785) 239-4263.

7. ADDITIONAL INFORMATION

Access Control Procedures: All individuals 16 and older must possess a Federal ID Card or a Fort Riley Access Pass or badge to recreate on Fort Riley. To acquire an access pass visit the installation's Visitor Control Center (Bldg. 885) just south of the Henry Gate Access Control Point (Exit 301, U.S. Interstate 70) Monday through Friday from 5 a.m. to 9 p.m. and 8 a.m. to 4 p.m. on weekends and federal holidays.
